The purpose of this MCCP is to capture final refinements to the Market Code and Code Subsidiary Documents (CSDs), required as a consequence of the development of the September 2015 Release: Namely, to capture the required Market Code and CSD changes which have not already been captured in the Approved Changes that form the scope of that Release. The MCCP also picks up some inconsistencies and or gaps identified from previously Approved changes.

# **General Description**

The Market Code and CSD changes proposed in this MCCP are required as a natural consequence of developing the Approved Changes for the September 2015 Release. In particular, not implementing this change would leave gaps in the Market Code and/or CSDs. However, it should be noted that the changes described in this MCCP are to ensure that the intent of the Approved Changes that are pertinent to the September 2015 Release are fully reflected in the Market Code and CSDs.

This MCCP also incorporates the legal drafting for MCCP183 – CC, which was issued by the Commission in June 2015 and discussed at the June Technical Panel.

#### CSD0102 -

 Identifies explicitly the timescales for the Application Window in Section 2.1.2, Step a and reflects these correctly in Sections 2.2.1 and 2.3 (i.e. within 6 BDs and 20 BDs of the RSD, inclusive), to make the CSD fully consistent with the Market Code, as a response to an audit observation.
