**A.2.a. ISSUE OR DEFECT WHICH THIS MCCP / OCCP SEEKS TO ADDRESS
Required under Market Code Parts 8.7.1 (ii) (b) and 8.8.1 (ii) (b)**

This MCCP seeks to address two issues with the drafting of the relevant CSD in MCCP051, *Notification to Scottish Water of changes in vacancy status*.

There are two issues for amendment;

(i) Despite the clear intention of MCCP051, the drafting of CSD0104 under MCCP051 did not provide, in all circumstances, for T012.2 vacancy updates to be provided to Scottish Water. In that drafting, the updates are only to be provided where the Supply Point is under Re-assessed charges.

(ii) In the definition of the T012.2 in MCCP051, the T012.2 carried optional data items which do not relate to vacancy information. The CSD0104 drafting did not in general provide for this information ever to be provided upon such data items being updated through a T012.1. However, it was arguably less clear as to the intended behaviour if both the vacancy information and another data item were updated at the same time, for a Supply Point under Re-assessed charges. For clarity, this change proposal removes such other data items from the T012.2.

Additionally, at the same time as resolving the two issues, this MCCP proposes to rename the T012.2 from “Update ...” to “Notify ...”, to distinguish in name between the CMA-incoming T012.1 “Update ...”, and the CMA-outgoing T012.2 which the T012.1 triggers.
