A.2.a. ISSUE OR DEFECT WHICH THIS MCCP / OCCP SEEKS TO ADDRESS Required under Market Code Parts 8.7.1 (ii) (b) and 8.8.1 (ii) (b)

CSD0105 states the following:

Steps a and b: Identify and classify Data Items requiring amendment

If a Code Party other than the Data Owner becomes aware of an error or missing data:

- i. in the case of a Trading Party they should contact the CMA. In particular, where the Trading Party is Scottish Water and the error pertains to the vacancy status of a Supply Point, Scottish Water may make an application to change the vacancy status of the Supply Point; provided that the Supply Point is marked as vacant in the Central Systems, and that the Supply Point is tradable or Temporarily Disconnected.
- ii. in the case of the CMA, they will contact the Contract Manager for the Data Owner.

Where a Data Owner identifies, or is informed by the CMA, that SPID Data is incorrect or requires a late update in the Central Systems, the Data Owner will initially determine whether the change requires a Retrospective Amendment or an Error Rectification by reference to CSD0301 (Data Transaction Catalogue), wherein each item of SPID Data is shown as either capable of late submission or correction by Error Rectification or Retrospective Amendment.

Up until 2013, the approach adopted to comply with the above process was that, for Retrospective Amendments, a Non-Data Owner would actually submit a draft Retrospective Amendment and the CMA would forward such draft to the Data Owner and invite the Data Owner to ratify and formally submit the Amendment. This approach proved to be problematic and inefficient, in that the CMA found itself acting as an intermediary between the two Parties, adding to the administrative burden, but without adding any value and the Non-Data Owner incurred a time and effort burden, in that they were required to create the data file for the Retrospective Amendment.

From 2013 onwards, the CMA either passed on such requests, or more frequently, advised Parties that they should contact the Data Owner directly. This arrangement had the benefit that the Non-Data Owner did not necessarily need to complete the data file for the Retrospective Amendment and meant that the interested Parties could determine the need or otherwise for the Retrospective Amendment, without having to communicate via the CMA.

This revised process has worked well and has now been enshrined in the automated Retrospective Amendment process that is offered by the CMA as an Additional Service.

It should also be noted that, for Error Rectifications, Non-Data Owners have never identified potential corrections to the CMA and correctional transactions have simply been made by the Data Owners, as required.

This MCCP seeks to amend CSD0105 such that it more comprehensively describes the working arrangements that have always been used for Error Rectifications and have been in place for over two years for Retrospective Amendments.

A minor amendment is also included to more correctly reflect current RA processing.
