The purpose of this MCCP is to capture a final refinement arising from the May 2016 Release, which primarily delivers MCCP192 (Effective Date of the POLR Process).

MCCP192 fully captures required changes to most CSDs:

- Enabling retrospective Designated Times for POLR transfers
- Introducing a new valid entry for the S Read Reason Code of 'PLR'
- Exclude S Reads with a reason code of 'PLR' from the R9 Performance Measures.

This MCCP identifies a final change required to give full effect to the above, namely, a change to CSD0301 Annex to incorporate the new valid entry of 'PLR' for the D3028 S Read Reason Code.
