The purpose of this M CCP is to capture final refinements to the Market Code and Code Subsidiary Documents (CSDs), required as a consequence of the development of the September 2017 Release: Namely, to consolidate the required Market Code and CSD changes which have already been captured in the Approved Changes that form the scope of that Release. The M CCP also picks up inconsistencies and or gaps identified from previously Approved Changes.

<b>General Description</b>		
The Market Code and CSD changes proposed in this M CCP are required as a natural consequence of developing the Approved Changes for the September 2017 Release. In particular, not implementing this change would leave gaps in the Market Code and/or CSDs. However, it should be noted that the changes described in this M CCP are to ensure that the intent of the Approved Changes that are pertinent to the September 2017 Release are fully reflected in the Market Code and CSDs.

**A.2.d. DRAFT LEGAL TEXT**  
 Required under Market Code Parts 8.7.1 (ii) (d) and 8.8.1 (ii) (d)

The purpose of this M CCP is to consolidate those changes being made to the Market Code and Code Subsidiary Documents arising from the September 2017 Release. In addition, the proposal includes minor refinements which have not already been captured in M CCPs.

The additional changes are:

- **The Market Code** – The Market Code has been amended to remove an incorrect reference to CSD0105 for dealing with transfer cancellations outside the cancellation window (which has not ever been the approach for dealing with such situations).
- **CSD0102** – The CSD has been further updated to re-instate minor corrections (made under M CCP172) to the visio diagram and to the process summary table regarding the inclusivity of the transfer window.
- **CSD0103** – The CSD has been further updated to remove references to transfers outside the cancellation window being covered in CSD0105, as this is not and has never been the approach to unwinding transfers.
- **CSD0205** – The CSD has been further amended to remove two references; one to TE Min charging and one to CSD0204, both of which were erroneous.
- **CSD0207** – The CSD has been further updated to correct a number of minor typographical errors and to make a number of editorial changes to improve wording or layout, as the case may be.
- **CSD0301**– The CSD has been further updated to reflect:
  - Modified Valid Set Description for the D4005 Cancellation Code F; ‘Self Supplier (Outgoing Licensed Provider)’ should be changed to ‘Self Supplier (Outgoing or Incoming Licensed Provider)’.

- New or modified error codes, as follows;

Error Code	Revised Text
DH	Sender must be Licensed Provider on Meter Read Date.
DS	Sender must be the Licensed Provider for the SPID continuously from the Meter Read Date to the HVI Received at Date.
DT	A Main Meter must not previously have been a Sub Meter on a Meter Network for the same SPID and a Sub Meter must not have been a Main Meter on a Meter Network on the same SPID.

- **CSD0301 Annex** – The Annex contains raw XML from the CMA CS code. This is generated directly from the code once the new version of the code is accepted by the CMA.
- **CSD0302** – This CSD has been further updated to remove some of the text in MCCP211 which included data extraction rules for Self-Supply and Specialist Supply MDS that included data that is not meaningful for the ‘snapshot’ basis of data included in the MDS. Specifically, the extraction rules cannot include prior registrations, nor pending transfers. These have been removed.
