The purpose of this MCCP is to capture final refinements to the Market Code and Code Subsidiary Documents (CSDs), required as a consequence of the development of the February 2018 Release and to consolidate the required Market Code and CSD changes which have already been captured in the Approved Changes that form the scope of that Release, along with the Commission Change MCCP222 -CC and MCCP220. The MCCP also picks up inconsistencies and or gaps identified from previously Approved Changes and Commission Changes.

A.2.b. DESCRIPTION OF THE NATURE AND PURPOSE OF THE MCCP / OCCP AND HOW IT MEETS THE MARKET CODE / OPERATIONAL CODE OBJECTIVES AND PRINCIPLES FOR THE MARKET DOCUMENTS Required under Market Code Parts 8.7.1 (ii) (c) and 8.8.1 (ii) (c)

General Description

The Market Code and CSD changes proposed in this MCCP are required as a natural consequence of developing the Approved Changes for the February 2018 Release. In particular, not implementing this change would leave gaps in the Market Code and/or CSDs. However, it should be noted that the changes described in this MCCP are to ensure that the intent of the Approved Changes that are pertinent to the February 2018 Release (and to MCCP222 - CC) are fully reflected in the Market Code and CSDs.

A.2.d. DRAFT LEGAL TEXT Required under Market Code Parts 8.7.1 (ii) (d) and 8.8.1 (ii) (d)

The purpose of this MCCP is to consolidate those changes being made to the Market Code and Code Subsidiary Documents arising from the February 2018 Release. In addition, the proposal includes minor refinements which have not already been captured in MCCPs.

The additional changes are:

- CSD0101 The CSD has been further updated to consolidate changes arising from MCCP220 with those drafted for MCCP214-CC. The CSD also includes further drafting identified in MCCP222 - CC.
- CSD0104 The CSD has been further amended to reflect the ability for SW to update the RV Transition Flag via the T012.7, as well as being able to update the Live RV. This change is not included in this MCCP, but has been incorporated into the CSD0104 re-drafting, presented in MCCP215. The CSD also includes further drafting identified in MCCP222 CC.
- CSD0201 The CSD has been further updated to;
 - Remove the RVF from the Settlement Disagg Reports, since this is a market wide parameter and would have added potentially 1000's of rows to Disaggs, all with the same number and could have been misleading for those SPIDs not in transition w.r.t. RV charges.
 - Add in a description of how the RV and Live RV Disagg settlement report rows will be populated.
- CSD0207 The CSD has been further updated to;
 - Incorporate the variants of Water and Sewerage Meter Annual Non-Volumetric Charges for RV and for Live RV (in addition to the default charges for Real Live RV).
 - Modify the labels for the variants of Property Drainage Prices and Roads Drainage Prices so that the default prices are those applied for Real Live RV, with RV and LRV variants applied to

RV and Live RV, respectively.

- CSD0301 The CSD has been further updated to reflect:
 - A minor clarification in the description of the T006.6, regarding the mechanism for use of a default value for the RVTF.
 - New error code DW (Transaction must include either a Live Rateable Value, or a Rateable Value Transition Flag).
- CSD0301 Annex The Annex contains raw XML from the CMA CS code. This is generated directly from the code once the new version of the code is accepted by the CMA.
