# A.2.d. DRAFT LEGAL TEXT Required under Market Code Parts 8.7.1 (ii) (d) and 8.8.1 (ii) (d)

The purpose of this MCCP is to consolidate those changes being made to the Market Code and Code Subsidiary Documents arising from the March 2019 Release. In addition, the proposal includes minor refinements which have not already been captured in MCCPs.

The additional changes are:

- Market Code Section 6.2.10 has been reverted to its pre-MCCP234 status, re-establishing the original
  timescales for performance related remedial reporting by Trading Parties at the end of the month
  following the relevant Performance Measures, rather than the end of the second month after the
  Performance Measures, since CMACPx186 has removed the need for the work-round of late running of
  the Performance Measures.
- Market Code Definitions. Current terminology in CSD0101 for the notional Live RV and default Live RV have now been defined, as these terms are defined in the Wholesale Scheme of Charges.
- CSD0101 The CSD has been further updated to reflect that 'notional Live RV' and 'default Live RV' are now defined terms.
- CSD0002 The CSD has been further updated to reflect the change of title for the R6 Performance Measures to 'SPID Status Updates', to be consistent with the requirements of MCCP227-CC. Measure R11A has also been updated to clarify that the R11 measure is run in August, reporting failures with the July Performance Measures.
- CSD0301 The CSD has been further updated to reflect:
  - Corrections; The D2045 and D2046 Data Items should be re-named (replacing 'Landlord' with 'MT').
  - o Existing Error Codes should be modified as follows;

also includes two additional aspects of configuration; the batch size limitation and the elapsed time for
polling when zero MIDs are returned, as described in CMACP273.
