The MCCP also picks up inconsistencies and or gaps identified from previously Approved Changes, including one minor inconsistency identified as a result of the 2020 Market Audit. | | |

| <p>The purpose of this MCCP is to consolidate those changes being made to the Market Code and Code Subsidiary Documents arising from the March 2021 Release. In addition, the proposal includes minor refinements which have not already been captured in those MCCPs.</p> <p>The additional changes are:</p> <ul style="list-style-type: none"> <p>CSD0101 – Registration: New Connections and New Supply Points. Section 4. For a T004.0, current arrangements are that the D3011 Meter Read Frequency must be one of Monthly or Biannually and cannot be Never (N), as this Meter Read Frequency is reserved for Pseudo Meters (created by a T004.3). This will be made explicit and validated by the CMA Central Systems.</p> <p>CSD0104 Part 1 – Maintain SPID Data (SPID Level) Section 4.1. MCCP256 set out drafting changes that allowed for changes of SPID Status to or from TTRAN to be SPID based, rather than core based. However, if the prior status of a WS SPID was PPDISC, this treatment in settlement must continue as a core based arrangement. Hence, where the prior status of a SPID is PPDISC, any change to TTRAN and subsequently from TTRAN must remain core based to ensure that the PPDISC treatment continues and ends across the core.</p> <p>CSD0104 Part 1 – Maintain SPID Data (SPID Level) Section 6.3. For a Customer Name update, if in a T032.0, the D2027 Customer Name and the D2028 Customer Name Type are both identical to the existing values, a T009.0 OK will</p> |

be issued to confirm that the transaction was successfully received, but a T032.1 will not, as there will not have been any update.

- **CSD0104 Part 2 – Maintain SPID data (Meter Level)**

Section 3.2. For a T004.0. current arrangements are that the D3011 Meter Read Frequency must be one of Monthly or Bi-annually and cannot be Never (N), as this value is reserved for Pseudo Meters (created via a T004.3). This will be made explicit and validated by the CMA Central Systems.

- **CSD0105 – Error Rectification & Retrospective Amendments.**

Section 2.2. The flow diagram does not show all the possible return transactions (as described in the main text of the CSD), but only the T013.1. The full list of transactions will be added. (This was identified via the Market Audit for 2020.)

- **CSD0301 – Data Transaction Catalogue.**

- T004.1. A new error code is required to accommodate the explicit obligation that a D3011 Meter Read Frequency cannot be set to Never (N). Such code will be NF (Meter read frequency must be B or M).
- T004.0/T004.1. The D3003 is an Optional Data Item, not Required. This will be corrected.
- HF error code: The wording should be modified as follows (red text), to reflect current design and practice: SPID must be ~~continuously~~either Tradable or PPDISC from the Effective From Date.
- ML error code: The wording should be modified as follows (red text), to reflect current practice and design: SA Indicator must be SA. ~~or~~RV or left empty, if Property Drainage is True.
- T009.3 to be removed as this transaction has never been implemented and never been identified in other CSDs.
