MCCP / OCCP DETAILS

ISSUE OR DEFECT WHICH THIS MCCP / OCCP SEEKS TO ADDRESS

Required under Market Code Parts 8.7.1 (ii) (b) and 8.8.1 (ii) (b)

A number of Issues have been identified which are concerned with the content, processing and notifications associated with the T012.0 (Submit SPID Data), T012.1 (Submit SPID Chargeable Data), T012.2 (Service Element Update Notification) and T012.4 (Notify Sewerage Service Elements) transactions, as follows:

Issue 17248 (Oct 2019). Consider removing the EFD from the T012.0 (Submit SPID Data). The
T012.0 is primarily concerned with the submission of changes to a SPID Address Block, but the
transaction also includes updates to the Customer Classification and the SIC Code and these
latter Data Items are dynamically varying (i.e. they carry Effective From Dates).

This results in T012.0 transactions having to involve crystallisation, whereby any change to the two Data Items that need an EFD can only carry EFDs that are dated after the most recent change to either the WS SPID or to any Associated SS SPID. This limits the scope for using the transaction and leads to increased usage of RAs.

Issue 17250 (Oct 2019). Treatment of the Free Text Field in the T012.0 (Submit SPID Data) and in the T012.1 (Submit SPID Chargeable Data). Both the T012.0 and T012.1 logic includes validation to ensure that the transaction can only be submitted for a WS SPID, or a stand-alone SS SPID and, if submitted for a WS SPID, the relevant updates are copied across to any associated SS SPID.

However, the T012.1 carries both WS SPID Data items (water related Service Elements) and core related Data Items (RV and Vacancy) and so the Free Text Field is not copied across, in case it pertains to WS SPID Data Items, rather than core Items. This reduces the information that is made available against an SS SPID.

- Issue 17295/E???? (May 2020). T012.2 (Service Element Update Notification) following a
 T012.1 submission are not sent to the Associated SS SPID LP, even if different to the WS
 SPID LP. It is further noted that this transaction notifies a Vacancy change, rather than any
 changes to Service Elements. This reduces the information that is made available and can
 cause a degree of confusion as to what is being provided.
- Issue 13740/E2690 (Feb 2021). T012.4 (Sewerage Service Element Update Notification) following a T012.3 submission are not sent to past responsible LPs, but such LPs can be impacted by changes to SS Service Element updates. This constitutes a reduction in the information that should be made available to an impacted Party.

DESCRIPTION OF THE NATURE AND PURPOSE OF THE MCCP / OCCP AND HOW IT MEETS THE MARKET CODE / OPERATIONAL CODE OBJECTIVES AND PRINCIPLES FOR THE MARKET DOCUMENTS Required under Market Code Parts 8.7.1 (ii) (c) and 8.8.1 (ii) (c)

General Description

Three distinct sets of improvements are proposed in this MCCP to address the issued identified above:

- Improved Notifications.
 - T012.2 (Service Element Update Notification) transactions should be issued to Associated SS SPID LPs, if they differ from the WS SPID LP.
 - T012.4 (Sewerage Service Element Update Notification) transactions should be issued to all SS SPID LPs who are, or have previously been, the responsible LP for the identified SPID at any time on or after the EFD for any update to the Sewerage Service Elements, as submitted via a T012.3 (Submit Sewerage Service Elements).

- Clarification for a Transaction. The T012.2 (Service Element Update Notification) transaction should be re-named as 'Notify Vacancy Update'.
- Creation of a new Transaction to allow for the T012.0 to become a static core-related data
 transaction, the T012.1 to become a dynamic WS SPID related transaction and a new
 transaction to be a dynamic core-based transaction, to ensure that all relevant information can
 be copied across from WS to SS SPIDs, to simplify processing and validation and to enhance
 the flexibility for retrospection (minimising the need for crystallisation). Specifically:
 - The T012.0 (Submit SPID Data) should be simplified by removing the dynamic variables from the transaction and consequently removing any crystallisation logic from this transaction.
 - The T012.1 (Submit SPID Chargeable Data) should be simplified by removing the core related Data Items, converting this transaction into a purely WS SPID related message.
 - o The T012.1 can then be renamed as 'Submit WS SPID Chargeable Data'.
 - A new T012.10 (Submit SPID Variable Data) should be created to cover core-based data that is dynamically varying. This transaction would be submitted by the responsible LP against a WS SPID (and copied across to any associated SS SPID), or a stand-alone SS SPID, to include the following Data Items:
 - SPID
 - EFD
 - Customer Classification
 - SIC Code
 - RV
 - Vacancy
 - Free Text Field

It should further be noted that associated changes are anticipated for the Chargeable Data RA and the Chargeable Data for a Sewerage SPID RA; ensuring that the first of these covers WS SPID Data, copied across to any associated SS SPID where relevant and the latter is for SS SPIDs, for any data that is sewerage specific, or for core-based data where the SS SPID value should differ from that for the WS SPID. However, these changes do not involve any Market Code or CSD changes and will therefore be progressed via a CMACPx.

CSD0104 (Part 1) should be modified, as follows (red text):

Section 2 Overview/Vacancy Status may change/Last para:

In the case of Vacancy, the Licensed Provider should notify the CMA of the Vacancy using Data Transaction T012.10 (Submit Chargeable SPID Variable Data) and any such submission must include a valid WCDS Code provided by Scottish Water, if such submission is made during the Term of the Wholesale Charge Deferral Scheme. Such WCDS Code will be calculated by the CMA and provided to Scottish Water.—2.1 (Submit Chargeable SPID Data).

Section 6.2 Process for a Change to Vacancy Status

Step a: Licensed Provider updates Vacant status to CMA [T012.10]

Where a Licensed Provider becomes aware that any premises have been either unoccupied or are no longer Vacant, it should notify a consequent change to the Vacancy status to the CMA.

In the case of Vacancy, the Licensed Provider should notify the CMA of the Vacancy using Data Transaction T012.10 (Submit Chargeable SPID Variable Data) and any such submission must include a valid WCDS Code provided by Scottish Water, if such submission is made within a period in which the Wholesale Charge Deferral Scheme is operating. Such WCDS Code will be calculated by the CMA and provided to Scottish Water.

In the case of the Supply Point being reoccupied, the Licensed Provider shall notify the CMA within 2 Business Days of becoming so aware, using the Data Transaction T012.10 (Submit Chargeable SPID Variable Data).

For re-occupancy after a period of vacancy, the Licensed Provider shall take account of whether the new occupier falls within the same Reassessed charges arrangements in place at the Supply Point as set out in the Wholesale Charges Scheme. Any consequent adjustment to the YVE or the Non Return to Sewer Allowance should be handled in accordance with CSD0104 Part 2 and Scottish Water shall ensure that the effective date of the revised Pseudo Meter information would equate to the date the application under the Wholesale Charges Scheme was made.

Where the Supply Point has a Related Water Supply Point, the change of vacancy status notified at the Water Services Supply Point will also be used for the associated Sewerage Services Supply Point.

Where a Sewerage Services Supply Point has a Related Water Supply Meter and a change of vacancy status is notified in error at the Sewerage Services Supply Point, the CMA will issue a Data Transaction T009.0 (Notify Error/Acceptance (LP)) displaying a message that indicates the Supply Point is a Sewerage Services Supply Point that has a Water Services Supply Point.

Step b: CMA Updates the Central Systems [T009.0]

CMA will process the T012.10 (Submit Chargeable-SPID Variable Data) and confirm acceptance or rejection using a T009.0 (Notify Error/Acceptance (LP)). If the T012.10 is accepted, CMA will update the Central Systems accordingly and cease or reapply charges as relevant.

Step c: CMA Notifications [T012.2, T012.10]

Within 1 Business Day of acceptance of a T012.10 (Submit Chargeable SPID Variable Data) pertaining to the Vacancy at a Supply Point, the CMA will notify Scottish Water and the Sewerage Services Supply Point Licensed Provider (if different to the Water Supply Point Licensed Provider) for any associated Sewerage Services Supply Point of that vacancy status, using Data Transaction T012.2 (Notify Chargeable SPID DataNotify Vacancy Update).

Section 6.6 Process for a Change to Service Elements

Section 6.7 Process for a Change to Miscellaneous Data

Step a: Update to Miscellaneous SPID Data [T012.0, T033.0]

The Licensed Provider is able to update certain SPID Data Items on an ad hoc basis, using Data Transaction T012.0 (Submit SPID Data) for data with no explicit effective date and using Data Transaction T012.10 (Submit SPID Variable Data) for data with an effective date.

The relevant data is listed in Section 4.3 of the Data Transaction Catalogue.

Within 2 Business Days of a SPID changing its Metered Building Water status, Scottish Water will provide details using Data Transaction T033.0 (Submit Metered Building Water). In the case of a Sewerage Services SPID with a related Water Supply Meter, the T033.0 submitted in respect of the associated Water Services Supply Point will be applied to the Sewerage Services Supply Point.

Step c: Notify Scottish Water [T012.9].

Following the successful submission of a T012.0, the SPID Data update will be notified to Scottish Water using a T012.9 (Notify WS/SS SPID Data Update).

Following the successful submission of a T012.10, the variable SPID Data update will be notified to Scottish Water using a T012.9 (Notify WS/SS SPID Data Update), excluding any changes to Vacancy or Rateable Value (which are notified separately).

Commentary: The CMA CS Notification Helper is a system module within the CS that identifies the scope for notifications arising from the successful submission of any relevant submission transaction. A generic change is first required for the Helper to include the possibility of old LPs being notified via suitable notification transactions.

The T012.4 can then be updated to include old LPs. It is considered that notification to old LPs is only relevant for SS SE updates, as these allow for EFDs that pre-date an RSD. The T012.4 need not be notified to associated LPs, as this is a notification that comes in against its specific SPID in the first place (i.e. it does not arise from an incoming submission for a WS SPID).

The T012.2 can also be updated to include the notification to associated SS LPs, but this is identified below, as there are additional URs that re-allocate the issue of a T012.2 after a T012.10, rather than after the T012.1, as now.

NOTE FOR CMA: The D4003 Text Comment field in the original T012.0 appear to be optional (not required, as stated in CSD0301) and in the original T012.1 is conditional on the WCDS flag being set to True and Vacancy being set to True and should therefore be identified as optional in CSD0301. This appears to be a legacy error in the CSD and should be changed, subject to confirmation. This also suggests that the D4003 would also be optional in the new T012.10.
