# A.2. MCCP/OCCP DETAILS

A.2.a. ISSUE OR DEFECT WHICH THIS MCCP / OCCP SEEKS TO ADDRESS Required under Market Code Parts 8.7.1 (ii) (b) and 8.8.1 (ii) (b)

MCCP259 (SPID Transfers) was implemented in September 2021 and delivered refinements to the SPID Transfer process that had been developed by the SPID Transfers Working Group.

One of the refinements included in MCCP259 was the establishment of an Erroneous Transfer RA that enabled cancellations to be progressed after the closure of the cancellation window (which limits the timescales for the submission of cancellation transactions – T010.0s or T010.1s) and after a transfer has taken place. Only two reasons for use of the Erroneous Transfer RA were allowed for: Error (using the D4005 Cancellation Code of 'E'), or No New Customer (using the D4005 Cancellation Code NN). Use of the NN Cancellation Code also carried with it validation to check that the prospective customer and/or the date for such customer to be registered at the premises, as identified in the originating transfer transaction – The T003.1 were in fact inconsistent with the customer so registered at the premises, with the attendant effective date.

It has subsequently been recognised that these arrangements also allowed for the NN Cancellation Code to be used in a T010.1 transaction (Cancel Registration – Outgoing). However, it is not clear that this would be appropriate since the basis for the 'No New Customer' cancellation is that the originally identified prospective customer and/or the date at which such customer became effective at a premises did not materialise post-transfer and any T010.1 can only be submitted ahead of such transfer.

Currently, any T010.1 submitted with a Cancellation Code of NN would result in a transfer being cancelled. Such a position is at odds with the intent of the changes implemented under MCCP259, which sought to improve the rigour and basis for transfers and any subsequent cancellations.

# **General Description**

This proposal seeks to establish the use of NN Cancellation Code in a manner that respects the definition of that code: That a prospective customer and/or date of such customer becoming effective at a premises did not materialise after the event.

This requires the following changes to be made:

- CSD0301 to be changed, removing the NN Cancellation Code from the valid set.
- Adding NN as a Cancellation Code to the Additional Services Schedule, along with E, as options to be used in the Erroneous Transfer RA.
- CMA CS changes to exclude NN as a valid Code for a T010.1.

Indicative User Requirements are as follows:

**UR 1 T010.1 Transaction (Cancel Registration – Outgoing).** The validation for the T010.1 should be modified such that the validation for the use of appropriate D4005 Cancellation Codes should reject the inclusion of the value NN, via the T9 Helper, with existing error code AS.

**Commentary:** Although CSD0301 will cease to identify NN as a D4005 valid value, it is convenient for the CMA CS to retain this as a valid value, albeit not valid for use in a T10 txn, but available to be used in the Erroneous Transfer RA.

**UR 2 LVI.** The T010.1 submission page should be modified to remove the NN Cancellation Code from the drop-down options.

**UR 4 Additional Services Schedule.** The AS Schedule should be modified to explicitly identify that the Erroneous Transfer RA must include either the D4005 Cancellation Code value of E, or a Cancellation Code of NN.
