#### A.2. MCCP/OCCP DETAILS

A.2.a. ISSUE OR DEFECT WHICH THIS MCCP / OCCP SEEKS TO ADDRESS Required under Market Code Parts 8.7.1 (ii) (b) and 8.8.1 (ii) (b)

This proposal has been created on request from Scottish Water and follows consideration of which Trading Party constitutes the natural owner of the SPID Address Data.

There are a number of distinct address related Data Items:

- The Postal Address Format (PAF) elements of the Address Block (D5001 to D5013), applicable separately to SPIDs, Meters and DPIDs and under the ownership of SW, except for the SPID Address, which is created by SW, but transfers to the LP following successful registration.
- The SAA Data (elements of the Address Block D2037 to D2040), applicable to SPIDs, owned by SW and
- The GIS Data (D3017 to D3019), applicable to Meters and owned by SW (except for the D3019 GIS Z Free Descriptor; owned by SW or the relevant LP).

The relevant Transactions pertaining to these Data Item sets are as follows:

- T001.0 (Request New SPID) that includes the PAF elements of the Address Block and the SAA Data, submitted by SW.
- T004.0 (Request New Meter) that includes the Meter (PAF) Address Data and the GIS Data, submitted by SW
- T012.0 (Submit SPID Data) that includes the SPID PAF Address Data, submitted by the LP.
- T012.5 (Submit SAA/UPRN Data) that includes the SAA Data, submitted by SW
- T013.0 (Submit Meter Data) that includes the Meter (PAF) Address Data and the GIS Data, submitted by SW
- T013.2 (Submit Meter Location) that includes the GIS Data, submitted by SW or an LP
- T021.0 (Create New DPID) that includes the DPID (PAF) Address Data, submitted by SW
- T027.0 (Update DPID Data) that includes the DPID (PAF) Address Data, submitted by SW.

The SAA Data (SAA Reference, UPRN and associated Absence Codes) was introduced in March 2015 and is under SW's ownership. These are assessed against SPID cores (currently, over 86% of SPIDs have a live match to the SAA, with the remaining 14% having valid absence codes). This assessment is an ongoing process, involving managing a premises register and modifying SPID configurations (splits and merges).

However, SW has no mechanism to update the SPID (PAF) Address following such reviews and this can result in inconsistencies in market data across market participants and the CMA. These inconsistencies, along with others that may arise between SPID (PAF) Address, SAA Data, Meter Address and DPID Address, can create operational difficulties for field activity when locating premises, meters, or discharge points.

A.2.b. DESCRIPTION OF THE NATURE AND PURPOSE OF THE MCCP / OCCP AND HOW IT MEETS THE MARKET CODE / OPERATIONAL CODE OBJECTIVES AND PRINCIPLES FOR THE MARKET DOCUMENTS

Required under Market Code Parts 8.7.1 (ii) (c) and 8.8.1 (ii) (c)

#### **General Description**

The proposal is to transfer ownership of the SPID (PAF) Address Data Items from the Licensed Provider to Scottish Water, consistent with the address referencing implemented in March 2015 and the current ownership of other address data, to create a consistent, single owner for all address related data. This is also consistent with the direction taken by the English market.

In practice, this means that the T012.0 transaction would be submitted by SW, instead of the LP. This, incidentally, also means that the D2043 LP Connection Reference would also be under the ownership of SW consistently: It currently sits with SW when a new SPID is created (albeit notified to SW by the LP) and is then also updated via the T012.0.

One additional change to support this is to create a new notification transaction, since the existing T012.9 will now need to be used to notify changes in SPID PAF Address (made by SW via the T012.0) to LPs. This necessitates the SPID Variable Data that is currently also notified via the T012.9 (following changes made via a T012.10 by the LP) to be notified to SW via a new notification: a T012.11.
