#### A.2. MCCP/OCCP DETAILS

A.2.a. ISSUE OR DEFECT WHICH THIS MCCP / OCCP SEEKS TO ADDRESS Required under Market Code Parts 8.7.1 (ii) (b) and 8.8.1 (ii) (b)

Deregistrations don't relate to physical disconnections (which are processed via the permanent or temporary disconnection process as appropriate) but to logical removals of Supply Points from the market because a property is no longer (or never was) an eligible premises.

The Market Code requires Scottish Water to update the Central Systems within 2 Business Days of undertaking a change of status (interpreted as being the effective date of the deregistration). This is a legacy of the introduction of the deregistration process many years ago when the existing KPI for disconnections has been applied to deregistrations because they use the same T15 transaction. Given that the change of status is initiated by the Customer and Scottish Water only become aware when either the Customer (via their LP) notifies us or the SAA update their records, the current Market Code KPI will very rarely be achievable – reflected in the 4% CMA audit compliance rate. It's also worth noting that if SW initiate a deregistration, process 31 of the Operational Code requires us to give the LP 20 Business Days' notice before processing the transactions – making achievement of the Market Code 2 Business Day target impossible for any changes which SW identify via updates at the SAA.

Over time, individual changes to CSD0104 and the Operations Code have had the unintended consequence of inconsistent and/or ambiguous descriptions of the milestones and timescales within CSD0104 and between CSD0104 and the Operational Code.
