#### 1. Minute

AH noted that all actions were now complete. MCCP296 was forwarded on to WICs for consultation. There were no Change Proposals withdrawn or rejected. AH noted that OCCP073 relating to Customer Requested Disconnects had now been implemented.

AH noted no new Commission Changes had been approved or introduced. No new Bulletin or Guidance Notes had been issued since the last meeting.

No new MPF / TP dates had been proposed, and the meeting was reminded that the current plan was to host the December 2024 meeting in person at the CMA's offices in Stirling.

## MCCP303 Future-Dated Transactions - Live RV

the basis that the functionality used to upload any batches is yet to be agreed by the Market. CMA will prepare the Final Report and submit to WIC for consultation.

#### 5. Forward Planning Report

AH noted that CMACPx272 and CMACPx274 have now been delivered. Both were additional services to amend historical SPID data.

AH noted that since the previous update we have invoiced £166k for Q1 performance charges. The July CMA Board approved the use of £15k of performance charge funds to support the delivery by the CMA of the Smart Metering and TTRAN workshops mentioned at the last TP meeting. These meetings were not in the original budget and will be delivered by a contractor resource.

The July Board has also approved the use of £65k performance charge funds for the delivery of the Central Systems extended opening hours proof of concept project. The Board has also released £12k of perfomrnace charge funds on behalf of the Senior Stakeholder Group for the completion of a baseline draft of the Code of Practice.

The available performance charge cash now stands at just under £1.94m.

AH also noted that the late payment table for the new FY24/25 was now updated.

#### 6. Water Commission Update



CD advised that MCCP296 would be issued for consultation shortly. AH asked about any license updates and CD advised that they were currently considering a License Revocation request from ThreeSixty Water.

CD advised that they had now published a consultation on the Draft Methodology regarding the Strategic Review of Charges for 2027-2033. The document is available on WICS website and outlines our proposed approach for how charge caps will be set for the 6 year period.

There being no further business, DS closed the meeting.
