General Description

There may be a change of occupancy following a temporary disconnection. LPs can currently update the Vacancy status of a SPID, but in order to maintain accuracy of the Market data, LPs also require the ability to update the Customer Name while the SPID status is TDISC. This would highlight the change of occupancy to Scottish Water and trigger consideration of returning the SPID to tradable status.

There are other scenarios where the Customer Name should be updated for a SPID that is Temporarily Disconnected. For example, the LP may discover that the Customer Name in the Central Systems is out of date, or the Customer may change its company name registered at Companies House. The present arrangements do not allow these sensible and necessary updates to be made.

6.3 Process for a Change to a Customer Name.

Step a: Licensed Provider Updates Customer Name [T032.0]

The Water Supply Point Licensed Provider will notify the CMA of a change to a Customer Name (and/or Customer Name Type) at a connected Supply Point that is not Deregistered or Permanently Disconnected, no later than 2 Business Days of the new Customer Name (or Customer Name Type) being notified to them, using Data Transaction T032.0 (Submit Customer Name). The Sewerage Services Supply Point Licensed Provider, where there is no associated Water Supply Point, will notify the CMA of a change to a Customer Name (and/or Customer Name Type) at a connected Supply Point that is not Deregistered or Permanently Disconnected, no later than 2 Business Days of the new Customer Name (or Customer Name Type) being notified to them, using Data Transaction T032.0 (Submit Customer Name).

If changes are identified for CSD0301 Data Transaction Catalogue Annex, these will not be provided in this MCCP, but will be provided following the deployment of the associated system updates. This is because the majority of CSD0301 Annex is system generated automatically and can only be updated after associated changes have been incorporated into the relevant system.
