1. Purpose and Scope

This document sets out Performance Standards to be applied to the performance of Trading Parties with effect from 1st April 2025 in accordance with Part 6 of the Market Code. Performance Standards for the period 1st April 2011 to 31st March 2025 are set out in earlier versions of this Code Subsidiary Document.

2. Performance Standards and Performance Standard Charges

- 2.1 The Performance Standards listed in Table 1 below have been designed to target performance in relation to high-priority tasks where a failure to carry out the task is likely to have a direct impact on the accuracy of Wholesale Charges calculations by the CMA.
- 2.2 For the purposes of the Market Code a Trading Party will be regarded as having failed a Performance Standard where it has failed to submit the relevant data on time. For the avoidance of doubt, only transactions which pass CMA validation will be considered as to whether they contain relevant data or not. The CMA will not take into account any messages, which either fail validation or are otherwise rejected, in the measurement of Performance Standards.
- 2.3 The Performance Standards R1 to R10 will be calculated monthly for the preceding calendar month.
- 2.4 Performance Standard Charges shall apply in accordance with Section 6.2 of the Market Code.
- 2.5 Performance Standard Charges will be applied at four levels. From 1st April 2025, the charges will be:
- Level 0 Charge £0
 - Level 1 Charge £10
 - Level 2 Charge £25
 - Level 3 Charge £40
- 2.6 The Performance Standard Charges will be designated as CMA Performance Standard Charges or SWLP Performance Standard Charges in accordance with Table 1.
- 2.7 For the purposes of performance standards, the following timing conventions will be used:
- **Calendar Days;**
 - If a period start, or other date and time, is identified on a Calendar Day, it should be taken that the period starts at the second beginning at 00.00.00 on that day.
 - If a period end is identified on a Calendar Day, it should be taken that the period ends at the beginning of the second of 23.59.59 on that day.
 - **Business Days.** Where a date and time needs to be identified against a Business Day (BD), the Business Day will be identified, as follows;
 - If received during Business Hours on a BD – that BD.

- If received after Business Hours on a BD – the next BD.
- If received prior to Business Hours on a BD – that BD.
- If received on a non-BD – the first BD after the non-BD.
- Business Hours are defined as being from the start of the second beginning at 05.00.00 to the end of the second beginning at 22.59.59 inclusive.

3. Performance Standards Charges - SW

3.1 The CMA will invoice SW quarterly in respect of the Performance Standard Charges to ensure that following the final quarter, the total amount invoiced in respect of the Year will be in accordance with the Market Code Section 6.2.6(a).

3.2 The aggregate amount of Performance Standard Charges payable by Scottish Water in accordance with the Market Code Section 6.2.6(a) is

$$PSC^Y = PSC_{CMA}^Y + PSC_{SWLP}^Y$$

where

PSC^Y are the Performance Standard Charges payable in respect of the Year;

PSC_{CMA}^Y are the CMA Performance Standard Charges payable in respect of the Year; and

PSC_{SWLP}^Y are the SWLP Performance Standard Charges payable in respect of the Year

In the above expression,

$$PSC_{CMA}^Y = \min\left(\sum_{q=1}^4 PSC_{CMA}^q, PCP^Y \times \sum_{q=1}^4 QR^q\right) \text{ up to 31 March 2028}$$

$$PSC_{CMA}^Y = \sum_{q=1}^4 PSC_{CMA}^q \text{ from 1 April 2028}$$

$$PSC_{SWLP}^Y = \sum_{q=1}^4 PSC_{SWLP}^q$$

where

PSC_{CMA}^q are the CMA Performance Standard Charges payable in respect of quarter q ;

PSC_{SWLP}^q are the SWLP Performance Standard Charges payable in respect of quarter q ;

PCP^Y is the Performance Cap Percentage for the relevant Financial Year;
and

QR^q is the sum of the R1 Settlement charges for the quarter q payable to SW as determined at the date of the invoice for the Performance Standard Charges for that quarter.

Quarters up to 31 March 2028

3.3 In respect of the first quarter, the CMA will invoice SW for the following reconciled CMA and SWLP Performance Standard Charges

(i). $RPSC_{CMA}^{q=1} = \min(PSC_{CMA}^{q=1}, PCP^Y \times QR^{q=1})$; and

(ii). $RPSC_{SWLP}^{q=1} = PSC_{SWLP}^{q=1}$;

3.4 In respect of subsequent quarters Q , the CMA will invoice SW for the following reconciled CMA and SWLP Performance Standard Charges:

(i). $RPSC_{CMA}^Q = \min(\sum_{q=1}^Q PSC_{CMA}^q, PCP^Y \times \sum_{q=1}^Q QR^q) - \sum_{q=1}^{Q-1} RPSC_{CMA}^q$

(ii). $RPSC_{SWLP}^Q = PSC_{SWLP}^Q$

Quarters after 1 April 2028

3.5 In respect of each quarter, the CMA will invoice SW for the following CMA and SWLP Performance Standard Charges

(i). PSC_{CMA}^q ; and

(ii). PSC_{SWLP}^q ;

Clarifications

3.6 For the avoidance of doubt, once a value of QR^q is established for the invoice of CMA Performance Standard Charges for quarter q it will be used unchanged in the calculation for all subsequent quarters of the Year.

3.7 SWLP Charges will only be calculated for a Supply Point or meter that can be associated to a particular LP. Such association will be that the LP is responsible for the Supply Point, or meter, as the case may be. If a meter is a domestic meter, the responsible LP will be the LP responsible for the Main Meter in a Meter Network for which the domestic meter is the Sub Meter. Where no such association can be made, no SWLP Charges will be calculated.

4. Performance Standards Charges - LPs

4.1 The CMA will invoice each Licensed Provider quarterly in respect of the Performance Standard Charges to ensure that following the final quarter, the total amount invoiced in respect of the Year will be in accordance with the Market Code Section 6.2.6(b). In particular, the CMA will invoice each Licensed Provider in respect of the CMA Performance Standard Charges payable by the Licensed Provider to the CMA and credit each Licensed Provider with the SWLP Performance Standard Charges payable to the Licensed Provider

4.2 The aggregate amount of Performance Standard Charges payable by each Licensed Provider in accordance with the Market Code Section 6.2.6(a) is

$$PSC^Y = PSC_{CMA}^Y - PSC_{SWLP}^Y \text{ where}$$

PSC^Y are the Performance Standard Charges payable by the Licensed Provider in respect of the Year;

PSC_{CMA}^Y are the CMA Performance Standard Charges payable by the Licensed Provider for the Year; and

PSC_{SWLP}^Y are the SWLP Performance Standard Charges payable to the Licensed Provider for the Year; and where

$$PSC_{CMA}^Y = \min\left(\sum_{q=1}^4 PSC_{CMA}^q, PCP^Y \times \sum_{q=1}^4 QR^q\right) \text{ up to 31 March 2028}$$

$$PSC_{CMA}^Y = \sum_{q=1}^4 PSC_{CMA}^q \text{ from 1 April 2028}$$

$$PSC_{SWLP}^Y = \min\left(\sum_{q=1}^4 PSC_{SWLP}^q, PSC_{CMA}^Y\right)$$

In the above expression,:

PSC_{CMA}^q are the CMA Performance Standard Charges payable in respect of quarter q

PSC_{SWLP}^q are the SWLP Performance Standard Charges payable in respect of quarter q ;

PCP^Y is the Performance Cap Percentage for the relevant Financial Year; and

QR^q is the sum of the R1 Settlement charges for the quarter q payable to SW as determined at the date of the invoice for the Performance Standard Charges for that quarter.

Quarters up to 31 March 2028

4.3 In respect of the first quarter, the CMA will invoice the Licensed Provider for the following reconciled CMA Performance Standard Charges

$$(i). \quad RPSC_{CMA}^{q=1} = \min(PSC_{CMA}^{q=1}, PCP^Y \times QR^{q=1});$$

and credit the Licensed Provider with the following reconciled SWLP Performance Standard Charges:

$$(ii). \quad RPSC_{SWLP}^{q=1} = \min(PSC_{SWLP}^{q=1}, PSC_{CMA}^{q=1});$$

4.4 In respect of subsequent quarters Q , the CMA will invoice the Licensed Provider for the following reconciled CMA Performance Standard Charges:

$$(i). \quad RPSC_{CMA}^Q = \min(\sum_{q=1}^Q PSC_{CMA}^q, PCP^Y \times \sum_{q=1}^Q QR^q) - \sum_{q=1}^{Q-1} RPSC_{CMA}^q$$

and credit the Licensed Provider with the following reconciled SWLP Performance Standard Charges:

$$(ii). \quad RPSC_{SWLP}^Q = \min(\sum_{q=1}^Q PSC_{SWLP}^q, \sum_{q=1}^Q PSC_{CMA}^q) - \sum_{q=1}^{Q-1} RPSC_{SWLP}^q$$

Quarters after 1 April 2028

4.5 In respect of each quarter, the CMA will invoice the Licensed Provider for the following CMA Performance Standard Charges

$$(i). \quad PSC_{CMA}^q;$$

And credit the Licensed Provider with the following reconciled SWLP Performance Standard Charges.

$$(ii). \quad RPSC_{SWLP}^q = \min(PSC_{SWLP}^q, PSC_{CMA}^q);$$

Clarifications

4.6 For the avoidance of doubt, once a value of QR^q is established for the invoice of CMA Performance Standard Charges for any LP for quarter q it will be used unchanged in the calculations for the same LP for all subsequent quarters of the Year.
